## FEES FROM SEPTEMBER 2018

I am writing to tell you about Acorns' fees for next year, which take effect from September 2018. As you know, Acorns is a non-profit making charity, run by a committee of parent volunteers. When setting our fees we aim to cover our basic running costs and expenses. We review our fees annually and we always make sure that our charges are as low as we can afford.

This year we are increasing our fees by 9p per hour, and this will help parents easily calculate our top up fees. Surrey County Council have increased their FEE contribution (for the Free Early Entitlement) from 4.51 per hour to 4.60. By raising our fees to match FEE funding, the top up remains easy to calculate at £2 per hour. FEET (Free Early Entitlement for Two Year Olds) has remained at £5.88. If you think you may be entitled to claim for FEET funding please tell us.

The new fees are set out below.

Morning	9.00am -12.00 noon	£6.60	<b>£19.80</b>	3 hrs <b>(£6 top up)</b>
Morning & Lunch	9.00am - 1.00pm	£6.60	<b>£26.40</b>	4 hrs <b>(£8 top up)</b>
Whole Day	9.00am - 2.45pm (Although this session is 5.75 hours, only 5 hours FEE/FEET can be claimed)	£6.60	<b>£37.95</b>	5 hrs <b>(£14.95 top up) (or £12 x 3 = £36 for 3 long days)</b> When 3 long days are booked to use the 15 hour entitlement, top up is reduced to £36 per week as this helps us plan for availability.

The hourly rate for FEE (Free Early Years Entitlement) is £4.60, and this is claimed by Acorns on your behalf. You will be asked to complete forms each term detailing hours you will be claiming. Although the FEE funding doesn't cover the whole cost it greatly reduces the amount you have to pay yourself. Children are eligible for FEE from the term following their 3<sup>rd</sup> birthday. Children may also be eligible for FEET (from the term following their 2<sup>nd</sup> birthday). Some families may be entitled to an additional 15 hours funded time (15 universal hours + 15 additional hours). Please look on our website for more information about FEET or 30 hours funding.

Please talk to Cary or Wendy if you have any concerns or questions about fees, or FEE funding. A letter detailing employers voucher schemes is available on our website. This is a method of paying for nursery fees with pre-taxed income. Thank you for choosing Acorns, we value and welcome your children with a caring, committed attitude. Thank you to all returning families.
